The Planning Commission will consider re-zoning the following parcels from the AP Agricultural Production Zoning District to the AR Agricultural Residential Zoning District. 75-013-020-002-00, 75-013-020-002-10, 75-013-020-002-20, 75-013-020-003-10, 75-013-020-004-01, 75-013-020-005-00, 75-013-020-007-00, 75-013-020-009-00, 75-013-020-010-00, 75-013-020-011-10, 75-013-020-012-00, 75-013-020-012-10, 75-013-020-012-20.

2. The Planning Commission will also be considering amendments to Section 305.4, Section 309.4 and Section 313.4 as it relates to parcel area and width requirements.

3. The Planning Commission will also be considering amendment to Section 403.3 as it relates to accessory buildings or structures.

The planning commission reserves the right to consider other determinations that may arise from further discussions.
